| BIENNIAL RENEWAL FEE - March Cycle - Renewal is March 31st every other calendar year | | |
| Targeted Case Management (CCM, CCM-S) to include any of the following endorsements: <i>Adult (A), Child (C), Adult & Child (AC)</i> | \$200 | To renew 1 credential, pay amount due. To renew 2 or more credentials, pay \$175 for the first credential plus \$100 for each additional credential. |

| Criminal History Report Fee (with application fee paid) | \$20 | Required for all applicants with a criminal history regardless of length of time since release from supervision. |
| Criminal History Report Fee (without application fee paid) | \$50 | Provides for a pre-application criminal history review and decision on eligibility for certification. |
| Late Renewal Fee | \$50 | Only accepted within 30 days of the renewal due date. On day 31, the credential becomes inactive. Applies to each individual credential. |
| Reinstatement Fee | \$150 | Only for credentials that have been inactive for no more than 3 years. |
| Child Welfare Provisional Extension Fee | \$75 | Only for eligible applicants. Must apply 30 days before the CWP expiration date. |
| Replacement FCB Certification Wall Certificate | \$15 | |
| Hard-copy FCB Certification Wallet Card | \$15 | Effective 6/1/2016, all wallet cards will be issued using an e-card format. Hard copy cards may be purchased. |
| Replacement IC&RC Certificate | \$35 | |
| Returned Check Fee | \$30 | |
| Credit Card Convenience Fee | \$5 | For all credit card transactions that require manual processing. |
| Manual Application Processing Fee | \$25 | Required for all hard-copy application submissions. |
| Proctoring Test Fee | \$30 | Payable to testing site. Not an FCB fee. |
